Revised Credit Transfer Agreement:

Introduction and Rationale:

This Agreement supports the ongoing educational partnership between the University of Wisconsin Oshkosh and the WTCS institutions offering Associate Degrees as named above. This Agreement specifies the transfer of credit from the Associate Degrees named above to the Bachelor of Science Degree in Human Services Leadership at UW Oshkosh, in recognition that these programs prepare students for admission to this degree completion program. The underlying assumption for this Agreement is that the Technical Colleges provide a foundation of occupational courses relevant to the Human Services field and the University provides the upper-level courses required within the Human Services Leadership program.

Conditions:

The terms of this Agreement apply only for the purposes of entry to the Bachelor of Science degree in Human Services Leadership program at UW Oshkosh. WTCS students admitted to UW Oshkosh under the terms of this agreement who subsequently elect to pursue a degree and major other than the Bachelor of Science degree in Human Services Leadership will find the extended transfer of credit does not apply outside of this program.

Students from the WTCS programs listed above must have completed their Associate degree program with a cumulative grade point average of at least 2.75/4.0 for consideration for transfer under the terms of this document. The terms of the agreement do not apply to students who have completed only a portion of the required course work for any of the Associate degrees named above.

Transfer of Credit:

The Bachelor of Science degree in Human Services Leadership program at UW Oshkosh **will accept a maximum of 45 block credits** based on only the technical (non-general education) courses for the program in question. General education course credits MAY also transfer as specified in the Transfer Information System (TIS). This agreement abides by UW System policy to transfer a maximum of 72 credits earned at applicable two-year institutions to University of Wisconsin baccalaureate degree programs.

Course Waiver:

In addition to receiving the transfer of credit noted above, students who completed an internship as part of their WTCS Associate Degree program would not be required to take Human Services 325, Intermediate Internship. Students receiving such a waiver would take another course in order to satisfy the credit requirement for the degree.

Effective Date :




